Q & A – Revenue Ruling 70-604


Question – I've heard differing responses regarding whether or not commercial associations can make an election under Revenue Ruling 70-604. Since our commercial condominium association is required to file Form 1120, and we need a certain amount of money to operate on, this is an important issue for us. Can a commercial association make an election under revenue Ruling 70-604.

Answer – The IRS position is that commercial associations cannot use Revenue Ruling 70-604; it is only available to residential associations. I disagree with that position, and believe IRS will find itself on the losing end of an argument when push comes to shove.

My reasoning comes from the plain language of Revenue Ruling 70-604. For federal tax purposes, your commercial association is defined as a "condominium management corporation," which is the exact description of the organization that was the subject of Revenue Ruling 70-604. The Ruling does NOT state that the subject association was a residential association. Therefore, the Ruling must apply. Revenue rulings are rulings issued by IRS to provide expanded guidance to taxpayers on an area of tax law where the Code and Regulations do not provide sufficient explanation. The IRS is required to follow any revenue rulings it issues. Tax payers are not required to follow the Rulings, but may challenge them and be prepared to justify any variances to IRS.
