

At the end of the recent CAI National Conference, the Reserve Shop Talk session was attended by some of the largest reserve study company principals. The subject of setting industry standards on calculations and reporting was introduced. It was stated that many reserve study companies produce much differing report presentations while also producing different calculation results (using a variety of different undisclosed formulas for calculations).

While one attendee disagreed, others agreed. This may display a lack of and need for standardization of calculations and reporting. Different reserve study company reports should have the same resulting numbers if using identical data.

Finding Court Cases on HOA Pulse

You can access the "Legal Zone" from either the top menu or the left side "Pulse Features menu." If using the top menu, click on "State Legal Zone" and it will take you to a list of states. Select the desired state to get started. For an example, we will use Arizona. Once you click on Arizona you are directed to the "Arizona State Legal Zone." This is the Arizona home page and gives you several different options, including Arizona statutes, link to Arizona state government website, pending legislation, and **Arizona Case Law**, which is toward the middle of the page. Click on this selection and you are directed to a table listing of individual cases, listed in alphabetical order. Click on any case to read the full text of the case.

OR

A second option is to again click on the Legal Zone tab from the top menu and select the "Court Cases" option. This directs you to a search screen where you can search the entire court cases database and any of the more than 400 cases on the site. This screen gives you the option of search by state, court level, or case name, options that are not available from the State Legal Zone. If you select Arizona and click on search, you will get results of the same list of cases that appear on the court case listing from the State Legal Zone page. Select individual case name from results to read the full text of the case.
