I arrived at the annual meeting to find a crowd of nearly 300 people in attendance. The situation was beyond standing room only; the organizers couldn't even fit all the attendees within the clubhouse meeting room. I hadn't bothered to ask my friend what the issue was that he had mentioned, but seeing such a huge turnout immediately told me that it was a controversial issue. Noncontroversial issues do not draw crowds of nearly half the Association. Since my friend, the manager of the Association, was busy with his board as they addressed logistical issues related to the unexpectedly large attendance, I did not have an opportunity to speak with him before the meeting commenced, and I was myself consumed by my duties as inspector of elections. I simply had to watch events unfold.
