## California Tax Issues By Gary Porter CPA

California taxation of homeowners associations is still a mystery to many people. That's because the rules are a little complex, especially as compared to taxation of individuals in the state of California. Let's look at the basic rules that apply to taxation of California homeowners associations.

- 1) All corporations in California are automatically subject to the <u>franchise</u> tax unless they are exempt from taxation under one of the subsections of revenue and taxation code section 23701. The franchise tax is essentially a tax on gross receipts less allowable deductions. One of the key applications of this concept that potentially affects homeowners associations is that U.S. Treasury interest, which is generally considered exempt interest income under income tax rules, is taxable under the franchise tax rules.
- 2) Corporate homeowners associations can apply for exemption under Revenue and Taxation Code section 23701t. This requires filing exemption application Form FTB 3500, which is a significant process in itself. It also means that the Association must meet the qualifications set forth in that section of California code. taxable income.

## Halloween Safety Tips By HOA Pulse Staff


**Safety tips for trick-or-treaters** (See the full article for more tips):
